Celebrate an Indiana African American heritage trail!

The celebration will begin on

**Friday, August 15**

on the waterfront in Jeffersonville, Indiana,  
with the dedication of an historic marker for Hannah Toliver,  
a Jeffersonville resident who was convicted and imprisoned in 1864  
for allegedly assisting with the escape of an enslaved person.  
She was imprisoned but then pardoned the same year.

After the dedication ceremony which will include music and a re-enactment,  
a reception and dinner will be held at the Falls of the Ohio.

The cost is \$25.00 per person.

**Saturday, August 16**

another historic marker will be dedicated in Corydon, Indiana,  
for Oswell Wright, a free man of color who was arrested in 1857,  
convicted and imprisoned in 1859  
for allegedly assisting with the escape of an enslaved person.

After serving five years in the Frankfort Penitentiary  
he was released and returned to Corydon, where he died in 1875.  
Wright is buried in Cedar Hill Cemetery just inside the gates.

The cost of the luncheon is \$15.00 per person.

## Update on HR1239/S1709



*The good news:* Our legislative efforts on behalf of the National Underground Railroad Network to Freedom program (NTF) paid off in full in May of this year. That month, both the House and Senate passed versions of the large public lands omnibus bill containing the NTF Funding Reauthorization Act of 2007. The president quickly signed the bill into law.

That means the NTF is now legally authorized to receive up to \$2.5 million per year - the previous authorization had been \$500,000.

*The bad news:* Despite the new authorized funding level, operational funding for the NTF program remains at a critically low level.

A quick word here about the difference between an authorization and an appropriation... A program or agency may be authorized to receive a certain amount of federal funding per year (in the case of the NTF that amount is now set at \$2.5 million), but Congress may decide (for any number of reasons) that only a portion of that money be appropriated for the program.

*The worse news:* NPCA has been working to insert extra money into the FY09 budget for the NTF program. We've got some well placed allies aware of the program and its needs (thanks to your letters, calls, and e-mails) but the appropriations process here in DC is quickly devolving from farce into tragedy. Given the various holidays and recesses, Congress has about 6 weeks left to do any legislating and passing of bills. Negotiations over spending, off shore drilling, and a variety of other election year issues seems to be cooling the desire of many to pass a budget for the Interior Department (which covers the Park Service and thus the NTF program), and we're likely to see a continuing resolution (CR) in place of an actual overall budget for FY09.

For all the non C-SPAN II junkies, that means the NTF will be forced to linger on through FY09 with an operating budget somewhere in the neighborhood of \$483,000 - a sum that fails to cover the basic programmatic needs of the staff and program partners.

*The real good news:* Our work over the past 14 months has produced a solid network of NTF friends and activists. I intend to engage all of you in a new round of outreach efforts that we'll develop over the course of this coming summer and fall, and then implement in 2009.

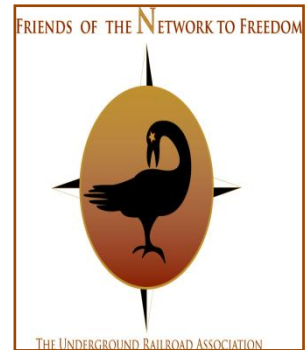
